# **FREE Tax Preparation**

In 2005, DC 37 helped over 3,100 members to get over \$7.6 million in refunds and savings on expensive tax preparation. This year, DC 37 is continuing our partnership with Food Change (formerly Community Food Resource Center, which will operate eleven centers in all five boroughs. Centers are located near many members' workplaces, homes or transportation hubs. Professional tax prepares are at each site. Please use the checklist to be sure you bring **all** the required documents.

In order to qualify for FREE electronic filing and tax preparation, a person with **dependent children** must have earned less than **\$40,000** TOTAL FAMILY INCOME INCLUDING SPOUSE INCOME. A person with **NO children** must have earned less than **\$20,000** TOTAL FAMILY INCOME INCLUDING SPOUSE INCOME.

Depending on income and family size, the member may also be eligible for the <u>Earned Income Tax Credit</u>, an additional amount of money that is paid to low income families in addition to their tax refund. Income limits for free tax services and the EITC are determined by the Internal Revenue Service.

### What You Need To Bring Social Security cards (you must bring an original card, a copy of the card or a copy of last year's tax return) or ITINs; and dates of birth for yourself and all family members you are claiming. W-2s for all jobs you held in 2005 and any other tax-related documents. Form 1099-G, if you received unemployment insurance in 2005 Form 1099-INT, if you received interest from a bank account in 2005. If you are claiming childcare expenses, documentation of expenses and childcare ageny's ID or Social Security number of provider. If you are filing your taxes with a spouse, you must bring your spouse. A sample check if you want direct deposit of your refund. 2 photo IDs (one government issued), if you wish to open a savings account and receive your refund within 7-10 days. District Counc
